Indo-Bangla Pharmaceuticals Limited, the prevalent pharmaceuticals company in the Country, is a reliable name in the pharmaceuticals sector of Bangladesh Like most local concern it made its inauguration in a humble way in 1954 founded by Ramlal Vattracharjjo in the heart of Barisal in the name of Indo-Pak Pharmaceutical Works (IPW). After independence, the government took control of the company and it was registered in Bangladesh under the privatization act in the name of Indo-Bangla Pharmaceutical Works. Later in 1982 government sold the company through auction to reputed businessman of Barisal late Alhaj Shamsuddin Talukder and late Alhaj Azizul Haque.

On June 18, 2014, Indo-Bangla Pharmaceuticals Works converted into a Private Limited Company under the companies Act 1994, vide registration no. C116665/14. subsequently 21 October 2014, converted into a Public Limited Company and there after became Publicly Listed Company listed with Dhaka and Chittagong Stock Exchange Ltd., in 2018.
